New York State Tax Credit: Residential building owners who install solar may be eligible for a tax credit for the lesser of 25% of the installed cost of the solar energy system (up to 25 kW on net-metered systems) after the NYSERDA incentive, or \$5,000.

Are New Yorkers eligible for a solar tax credit?

New Yorkers are eligible for the federal solar tax credit when they go solar. The credit equals 30% of the costs of a solar installation and directly reduces your federal income tax liability. The average solar system in New York will earn a federal solar tax credit of \$5,796.

What is a solar tax credit?

Also known as the Investment Tax Credit or Residential Clean Energy Credit, this federal incentive allows homeowners to get a tax credit for 30% of the cost of their fully installed solar panel system. Expenses include the materials and labor from your solar installation company.



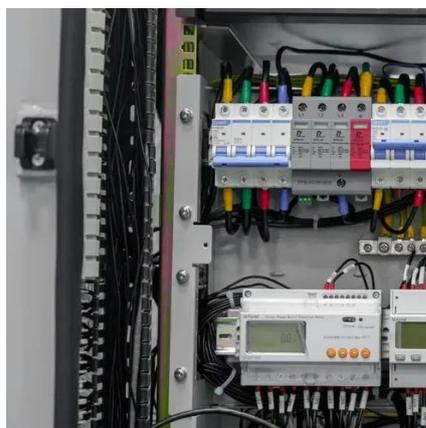
