Spain has launched an ambitious €700 million (around \$796 million) program to increase its energy storage capacity. This plan will add 2.5 to 3.5 gigawatts (GW) of storage. It includes pumped hydro, thermal energy storage, and battery systems. The goal is to improve how Spain uses renewable energy.

The European Commission has approved a €699 million Spanish scheme to support investments in energy storage facilities to foster the transition towards a net-zero economy. The scheme contributes to the achievement of the priorities of the European Commission for 2024-2029, based on the Political.


